Regulations for resumption of studies at Sahlgrenska Academy

(Translation of decision made by the Dean, September 4, 2019 – GU 2019/1743)

For all students, the prerequisites for further studies within the programme must be met at the latest date/time determined by the respective educational programme. The application for resumption must have been sent in on time.

Students at term 1 - Place guarantee has student who:

- Has been admitted to the current term via national admission (in round 1 and 2).
- Has had a study break for special reasons such as pregnancy / parental leave, social / medical reasons, student union assignments, military service or other circumstances (UHRFS 2013: 3).

Students who do not meet the requirements for a place guarantee (above) are prioritized as follows:

- 1. Has applied to a course for re-registration (in due time). Ranking is based on the amount of registered higher education credits (HP/ECTS) in Ladok within the programme when admission notice is given.
- 2. Has been placed as reserve in the national admissions.

Students from term 2 - Place guarantee has student:

- Who is moved up according to the regular course of study for the programme.
- Has had a study break for special reasons such as pregnancy / parental leave, social / medical reasons, student union assignments, military service or other circumstances (UHRFS 2013: 3).

Students who do not meet the requirements of the place guarantee (above) are prioritized as follows:

- 1. Has been denied continuation due to unmet prerequisites and who follows an individual study plan.
- 2. Has once before applied to the course, but was denied a place despite having the maximum number of higher education credits, in which case a random selection between two or more students had to determine the outcome.
- 3. Does not, for any reasons, follow the regular course of study at the programme or has not followed a previously established individual study plan.

Ranking within each priority group is based on the number of higher education credits awarded (in LADOK) within the programme. In the case of an equal number of higher education credits, a random selection is used. When multi-grade scale exists at the programme, grades will be used.

For all students, the application for resuming studies must be submitted no later than April 15 for courses given during the autumn term and October 15 for courses given during the spring term. Late applications can be considered (to have been received in time) if there are special reasons, such as illness or denial of continuation due to unmet prerequisites after the end of the application period. Late applications are ranked in date order based on when they are received at the university.

Incoming exchange students on agreements are handled according to rules determined by the education programme. A place should be offered, as far as possible, to the incoming student according to the exchange agreement and partner relations.

Application to the latter part of the programme is handled according to rules determined by the education programme. Admission to the latter part will only take place when students admitted to the programme and incoming exchange students have been offered a place.

These rules replace previous decisions (G 2013/907) and are valid from the start of the spring term 2020. Already made decisions according to previous rules apply in accordance with the content of the decision.

The proposal to revise the rules for course allocation and resumption of studies has been prepared by the Education Council's working group. The decision was made on September 4, 2019 (GU 2019/1743).
